

Movie Bookings - Terms & Conditions

Child Safety

- The parent/caregiver agrees to remain at the Shopping Centre through the duration of the Movie. It is important to retain proximity to the Cinema in the event the Parent/caregiver needs to be contacted or collect their child.
- The parent/caregiver agrees to return with the wristband stub provided at the time of registration, together with photographic identification, in order to collect their child.
- The parent/caregiver agrees to have a working phone on them at all times whilst their child is in the care of Stay'nPlay staff.
- The same parent/caregiver that registered the child at drop off needs to be the same parent/caregiver to collect the child, unless discussed with and noted by a Stay'nPlay staff member at the time of registration.
- The parent/caregiver must sign their child out of the movies it is a legal requirement.
- The parent/caregiver must ensure the movie is appropriate for the age of their child.

Registration & Collection

- The parent/caregiver agrees to fill out the registration form and bring it to the cinema.
- The parent/caregiver agrees to advise of any medical conditions, allergies, disabilities of the child at the time of registration.
- Children must be toileted before approaching the registration desk
- The parent/caregiver agrees to complete a Covid-19 screen questionnaire including disclosing any symptoms experienced in the last 14 days.
- The parent/caregiver agrees to complete the steps at the Stay'nPlay Hygiene Station before approaching the registration desk at the cinemas. This includes sanitising hands and checking in using a QR code for contact tracing purposes, as per health directives.

- If a group or families wish for their children to sit together, they should register at the same time with the same Stay'nPlay staff member at the cinema. This will ensure children are seated together.
- The parent/caregiver must remember to bring their TICKET when they return to collect their child.

During the Movies

- The parent/caregiver agrees to familiarise themselves and their children with the following rules during the movie:
 - ➤ All mobile phones should be switched off in the cinema, or left with parents/caregivers
 - ➤ If a child becomes upset, a Stay 'n play staff member may call the parent/caregiver to collect the child
 - > Parents are not able to stay during the movie with their child Exceptions will be considered for carers accompanying children with special needs
 - > Children cannot share food or drinks in the cinema
 - ➤ Children must stay in their designated seat whilst in the cinema, as per Covid-19 health directives
 - ➤ Children will be provided with food and 1 x drink of water if they need more please ensure they have had something to eat and drink before drop off
 - ➤ All reasonable care is taken with children's belongings and clothing. We are not responsible for any loss or damage to children's belongings or clothing.

First Aid

- If your child requires First Aid, a First Aid trained Stay'nPlay staff member will attend to him/her in the first instance and parent/carer will be contacted.
- If additional assistance is required Stay'nPlay may take the child to the Movie complex's First Aid site.

Behaviour

• If your child is disruptive and/or a threat to the safety of other children, they will be removed from the cinema, and you will be contacted to collect them.

Late Penalty

• Please collect your child at the designated time. If you are late, a penalty fee may apply.

Stay'nPlay's Duty of Care

 Stay'nPlay will always act in the best interests of your child and take all reasonable steps to ensure their safety and wellbeing; however, Stay'nPlay will not be held responsible for any accident or injury sustained at Stay'nPlay.

Photography

 In registering my child with Stay'nPlay, I consent to my child being photographed and acknowledge that the imagery may be used in social media or for marketing and/or promotional purposes by Stay'nPlay and/or the host shopping centre.
